#### **B.** Adjustments to Base Drainage Service Charges

Commencing July 1, 2014 the Base Drainage Service Charges set forth in A above shall be adjusted annually on the first day of July of each fiscal year by an amount equal to the percent change in the All Urban Consumers Index, U.S. City Average (ASCA), as supplied by the Bureau of Labor Statistics on the 1st day of January immediately preceding the July 1st date of adjustment, unless or until such time as new rates are set by the Board of Directors.
